RESOLUTION REQUESTING THE EXECUTIVE COMMITTEE OF THE PHILIPPINE MEDIATION CENTER OFFICE, PHILIPPINE JUDICIAL ACADEMY, SUPREME COURT OF THE PHILIPPINES TO ESTABLISH THE PHILIPPINE MEDIATION CENTER SATELLITE OFFICE IN ROXAS, ORIENTAL MINDORO WHICH SHALL CATER THE NEEDS OF THE LITIGANTS OF ROXAS, MANSALAY AND BULALACAO, ALL OF THE PROVINCE OF ORIENTAL MINDORO

“WHEREAS, in order to promote access to justice, promote party autonomy in the resolution of disputes or the freedom of the parties to make their own arrangement to resolve disputes and to assist the court in declogging their dockets, the Supreme Court designated the Philippine Judicial Academy which establish the Philippine Mediation Center who would facilitate the alternative dispute resolution and court referred and court related mediation;

“WHEREAS, the Philippine Mediation Center is the Office which facilitate alternative dispute resolution through court annexed mediation, where there is a process of settling disputes with the assistance of an acceptable, impartial and neutral third party called a mediator who helps both parties identify issues and develop proposals to resolve their disputes;


“WHEREAS, considering the possibility of amicable settlement or a submission to alternative modes of dispute resolution, the establishment of the Philippine Mediation Center Satellite Office in Roxas, Oriental Mindoro which shall cater the needs of the litigants of Roxas, Mansalay and Bulalacao, all of the Province of Oriental Mindoro shall redound to the social and economic benefits of its constituents; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Executive Committee of the Philippine Mediation Center Office, Philippine Judicial Academy, Supreme Court of the Philippines to establish the Philippine Mediation Center Satellite Office in Roxas, Oriental Mindoro which shall cater the needs of the litigants of Roxas, Mansalay and Bulalacao, all of the Province of Oriental Mindoro;






