“WHEREAS, in principle, evacuation centers will provide safe and temporary shelter to communities at potential risk of disaster. It provides lifesaving shelter to affected or vulnerable communities pre and at the point onset of natural disaster for a few days;

“WHEREAS, just recently, the first regional evacuation center situated in Barangay Poblacion, this Municipality was inaugurated and turned-over to the Local Government Unit of Bulalacao. The project was funded by the Office of the Civil Defense in partnership with the Department of Social Welfare and Development, the Department of Health and the Department of Public Works and Highways as the implementing agency;


"WHEREAS, during the onslaught of Typhoon Paeng, the first Regional Evacuation Center could not fully accommodate the evacuees that this Sanggunian is humbly requesting for another evacuation center to strengthen emergency response and recovery efforts of the LGU during calamities; **Now, therefore, be it...**


