### **RESOLUTION NO. 20-11-460**

**EARNESTLY REQUESTING THE DEPARTMENT OF BUDGET AND MANAGEMENT THRU SECRETARY WENDEL AVISADO TO ALLOCATE THE AMOUNT OF SEVENTY MILLION PESOS (PhP70,000,000.00) TO BE USED FOR THE CONSTRUCTION OF TWO EVACUATION CENTERS AT BARANGAY SAN ROQUE AND MAUJAO BOTH SITUATED IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**“WHEREAS**, Section 17 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities necessary, appropriate, or incidental to efficient and effective provision of basic services and facilities such as multi-purpose hall, multi-purpose pavement, plaza, sports center and other similar facilities;

**“WHEREAS**, the Department of Budget and Management (DBM) is responsible for the formulation and implementation of the National Budget, and the efficient and sound utilization of government funds and revenues to achieve the country’s development goals;

**“WHEREAS**, Bulalacao, a third class municipality located at the southernmost tip of Oriental Mindoro with a population of 39,107 based on 2015 census, has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

**“WHEREAS**, because of its location and climate type, Bulalacao is at high risk of weather disturbances and typhoons which causes flooding and other damages that affect the houses and the safety of the people;

"WHEREAS, these past few weeks Bulalacao was consecutively destructed by Typhoons Quinta, Rolly, Siony, Tonyo and Ulysses, and it had been a challenge for the local government to provide temporary shelter for the people who were eminently affected by the typhoons because of the lack of evacuation centers;

"WHEREAS, the provision of two evacuation centers in Barangay San Roque and Maujao in the Municipality of Bulalacao will support counter insurgency in conveying awareness to people showing that the Government is focused in giving welfare and development in the countryside, and providing them infrastructural facilities that shall be beneficial to the community at all times;

NOW, THEREFORE, BE IT, RESOLVED AS IT IS HEREBY RESOLVED, To: earnestly request the Department of Budget and Management thru Secretary Wendel Avisado to allocate the amount of seventy million pesos (PhP70,000,000.00) to be used for the construction of two evacuation centers at Barangay San Roque and Maujao both situated in the Municipality of Bulalacao, Province of Oriental Mindoro.
