EARNESTLY REQUESTING THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) THRU SECRETARY WENDEL AVISADO TO ALLOCATE THE AMOUNT OF EIGHTY FIVE MILLION PESOS (PHP85M) TO BE USED FOR THE UPGRADING/CONCRETING OF SAN ROQUE-SAN JUAN TO TAFARMA LOCAL ACCESS ROAD LEADING TO THE FAMOUS SUGUICAY ISLAND AND OTHER NEARBY BEACHES IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO
