"WHEREAS, Public Attorney's Office (PAO) is a government agency which provides indigent litigants, the oppressed, marginalized and underprivileged members of the society free access to courts by rendering legal services, counseling and assistance;

"WHEREAS, PAO inspires trust in the country's judicial system and encourage lawyers to engage in public service in consonance with the Constitutional mandate that "free access to courts shall not be denied to any person by reason of poverty" in order to ensure the rule of law, truth and social justice as components of the country's sustainable development;

"WHEREAS, the Municipalities of Roxas, Mansalay and Bulalacao, Province of Oriental Mindoro is lucky enough for the establishment of PAO in Roxas rendering free legal assistance to the poor residents against their rich and influential court opponents;




