EARNESTLY REQUESTING THE REGIONAL TRIAL COURT, ROXAS, ORIENTAL MINDORO TO EXPEDITE THE SPEEDY TRIAL OF THE CASE INVOLVING THE CLAIM OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO OVER THE ISLAND OF LIWAGAO

"WHEREAS, it is maintained by the Municipality of Bulalacao, Province of Oriental Mindoro that the territorial domain over the Island of Liwagao belongs to the Municipality of Bulalacao by virtue of historic right on legal title; as previous elections were held and geographical maps show that this island really belongs to Bulalacao;

"WHEREAS, the case entitled "Province of Oriental Mindoro and Municipality of Bulalacao versus Province of Antique and Municipality of Caluya docketed as Civil Case No. C-566 pending before the Regional Trial Court Branch 43, Roxas, Oriental Mindoro is now ordered to hear and decide the case with dispatch after the Temporary Restraining Order (TRO) was lifted by Supreme Court Decision dated June 8, 2016;

"WHEREAS, the Municipality of Bulalacao, Oriental Mindoro in its long desire of claiming the Island of Liwagao hopes for the immediate resolution of this dispute in favor of Bulalacao so that adequate delivery of basic services to the residents of Liwagao be made ready and available; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Regional Trial Court, Roxas, Oriental Mindoro to expedite the speedy trial of the case involving the claim of the Municipality of Bulalacao, Province of Oriental Mindoro over the Island off Liwagao;


