“WHEREAS, Bulalacao National High School (BNHS) situated in Barangay Campaasan, Bulalacao, Oriental Mindoro is a prone flood area where large volume of rain water is stocked in the street and inside the school campus resulting to the inconvenience of both the teachers and the students;


