### RESOLUTION NO. 17-07-180

**EARNESTLY REQUESTING SECRETARY ARTHUR TUGADE, DEPARTMENT OF TRANSPORTATION TO FACILITATE THE CONSTRUCTION OF A LIGHTHOUSE IN TAMBARON ISLAND OR MAASIN ISLAND, BULALACAO, ORIENTAL MINDORO**

**"WHEREAS**, a lighthouse is a tower or building structure designed to emit light from a system of lamps and lenses serves as navigational aid for maritime pilots at sea or on inland water ways;

**"WHEREAS**, the important purpose of a lighthouse is to mark a particular marine hazard such as dangerous rock or to mark an entrance or to allow seafarers to determine position at night, particularly before electronic navigation when sailors might make an initial landfall and be uncertain exactly where they were. The lighthouse keeper would also be available to rescue sailors in distress following a ship wreck;

**"WHEREAS**, during coastal navigation, a lighthouse accurately fixes to ensure safe passage to avoid sea tragedy resulting to losses of lives and properties;

**"WHEREAS**, Tambaron and Maasin Islands in the Municipality of Bulalacao, Province of Oriental Mindoro were recommended as the most appropriate place for a lighthouse due to its geographical location; Now, therefore, be it

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Earnestly request Secretary Arthur Tugade, Department of Transportation to facilitate the construction of a lighthouse in Tambaron Island or Maasin Island, Bulalacao, Oriental Mindoro;


