RESOLUTION REQUESTING THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) THRU SECRETARY ROY A. CIMATU TO FAVORABLY CONSIDER ENTERING INTO A CO-MANAGEMENT AGREEMENT WITH THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO REGARDING THE UTILIZATION OF CERTAIN HECTARES OF LAND SITUATED IN BARANGAY SAN JUAN, BULALACAO, ORIENTAL MINDORO THE TENURIAL INSTRUMENT OF WHICH WILL SOON EXPIRE UNDER THE NAME OF MAANI DEVELOPMENT CORPORATION (MADECO)

"WHEREAS, the vast track of land occupied by the Maani Development Corporation (MADECO) and located in Barangay San Juan, Bulalacao, Oriental Mindoro seems to have been abandoned for several years for reason unknown to us leaving the area neglected and unproductive;


"WHEREAS, the Local Government Unit of Bulalacao believes that such land will still be improved and become useful and more productive given the right management and financial support to fully implement the development projects needed in the area;


"WHEREAS, it is known to us that MADECO's tenurial instrument over the area will soon expire and us such the Local Government Unit of Bulalacao is strongly expressing its interest to introduce improvement and development to the subject area thru effective and responsible on-site management and this could only be done thru a co-management agreement with the DENR; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Department of Environment and Natural Resources (DENR) thru Secretary Roy A. Cimatu to favorably consider entering into a co-management agreement with the Local Government Unit of Bulalacao, Oriental Mindoro regarding the utilization of certain hectares of land situated in Barangay San Juan, Bulalacao, Oriental Mindoro the tenurial instrument of which will soon expire under the name of Maani Development Corporation (MADECO)


