RESOLUTION NO. 16-10-125

EARNESTLY REQUESTING THE HONORABLE REYNALDO V. UMALI, CONGRESSMAN, 2ND DISTRICT, ORIENTAL MINDORO TO PASS A BILL REVERTING OR RECLASSIFYING SOME FOREST ZONES SITUATED IN THE MUNICIPALITY OF BULALACAO INTO ALIENABLE AND DISPOSABLE LANDS (A & D)

"WHEREAS, Presidential Decree No. 705 states that proper classification, management and utilization of the lands of the public domain to maximize their productivity to meet the demands of our increasing population is urgently needed;

"WHEREAS, guided by the above purpose, there are forest zones situated in the Municipality of Bulalacao, Oriental Mindoro that need to be reassess for the multiple uses of forest lands and resources before it may utilize to optimize its benefits and equally important is for its protection, rehabilitation and development to ensure the continuity of their productive condition;

"WHEREAS, the Bureau of Forest Development shall have jurisdiction and authority over all forest lands and all forest reservations including watershed reservations presently administered by other government agencies or instrumentalities which this Body believed that through the intervention of Congressman Umali, this request shall be given due attention and prompt action; Now, therefore, be it


RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Honorable Reynaldo V. Umali, Congressman, 2nd District, Oriental Mindoro to pass a bill reverting or reclassifying some forest zones situated in the Municipality of Bulalacao into alienable and disposable lands (A & D);




