RESOLUTION NO. 21-03-107

RESOLUTION ASSURING THE NATIONAL FOOD AUTHORITY (NFA) THAT THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO HAS ALLOTTED ONE (1) HECTARE OF LAND TO BE EXCLUSIVELY USED AS SITE FOR THE CONSTRUCTION OF AN NFA WAREHOUSE

“WHEREAS, the National Food Authority (NFA) is one of the most important policy instrumentalities of the Philippine Government with respect to agricultural price policy and food security;

“WHEREAS, good warehouse and distribution system includes protection from insects, rodents ad birds, ease of loading and unloading, efficient use of space, ease of maintenance and management and prevention of moisture re-entering the grain after drying;

“WHEREAS, studies show that 25 to 50 percent of the total grain value such as quantity and quality was lost between harvest and consumption so that proper storage is vital to the stability of the country’s grain supply;

“WHEREAS, seeing the importance of a warehouse, the Sangguniang Bayan of Bulalacao passed Resolution No. 20-10-438 entitled “Resolution requesting the National Food Authority (NFA) thru Administrator Judy Carol L. Dansal to facilitate the construction of a NFA warehouse in the Municipality of Bulalacao, Province of Oriental Mindoro”, to which it is happy to note that NFA had given priority to realize the project;


"WHEREAS, to facilitate the immediate implementation of the project mentioned above, the Local Government Unit of Bulalacao allotted one (1) hectare of land from a private individual who committed to donate by way of "Deed of Donation" to the NFA where a warehouse is to be constructed; **Now, therefore, be it**

RESOLVED AS IT IS HEREBY RESOLVED, To: Assure the National Food Authority (NFA) that the Local Government Unit of Bulalacao, Oriental Mindoro has allotted one (1) hectare of land to be exclusively used as site for the construction of an NFA warehouse;






