RESOLUTION REQUESTING THE DEPARTMENT OF EDUCATION (DEPED) THRU SECRETARY LEONOR M. BRIONES TO CONSIDER BUDGET REALIGNMENT OR ADJUSTMENT FROM SAVED OR UNUTILIZED BUDGET FOR PROCUREMENT OF BOOKS AND CHAIRS AND CONSTRUCTION OF SCHOOL BUILDINGS TO PROCUREMENT OF MODULES, SUPPLIES, PRINTERS AND INFORMATION TECHNOLOGY (IT) EQUIPMENT AS DEPED ADOPT NEW LEARNING DELIVERY MODALITIES IN CONNECTION WITH COVID-19 PANDEMIC

"WHEREAS, pursuant to Republic Act No. 9155 also known as the Governance of Basic Education Act, the Department of Education (DepEd) was vested with the authority, accountability and responsibility of ensuring access, promoting equity, and improving the quality of basic education;

"WHEREAS, Section 2 of DepEd Order No. 007 s. 2020 states that the Department of Education is committed to ensure educational continuity amidst the challenges. Education must continue to give hope and stability, contribute to the normalization of activities in the country, facilitate development of our learners and bring normalcy to their lives, but health and safety of learners and personnel are of utmost importance and must be protected at all times;

"WHEREAS, because our country is under a state of public health emergency because of the COVID-19 pandemic, DepEd directed to avoid the traditional face-to-face learning in classroom and adopts new learning delivery modalities where there will be orientations, delivery of learning resources and on-line discussions;

"WHEREAS, Bulalacao, a third class municipality located at the southernmost tip of Oriental Mindoro with a population of 39,107 based on 2015 census, 25 percent of which are indigenous people called Hanunuo Mangyan, has a municipal government that promotes, upholds, and supports "Education for All" advocacy;

"WHEREAS, Bulalacao is confronted with many challenges in delivering new learning modalities because not all areas here have access to good internet services and majority of Bulalacaonons live below poverty line;

NOW, THEREFORE, BE IT, RESOLVED AS IT IS HEREBY RESOLVED, to: request the Department of Education (DepEd) thru Secretary Leonor M. Briones to consider budget realignment or adjustment from saved or utilized budget for procurement of books and chairs and construction of school building to procurement of modules, supplies, printers and information technology (IT) equipment as DepEd adopt new learning delivery modalities in connection with COVID-19 pandemic.
