“WHEREAS, last May 9, 2022 the election day in the Philippines was held all over the country where 65.7 million registered voters are opted to cast their votes in deciding the next Philippine President besides the more than 18,000 other elective positions, thus as per partial count of the Commission on Election (Comelec) there are 54.6 million Filipinos or 80.8% of the total registered voters participated the election;
