RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2017-05 OF BARANGAY BALATASAN REALIGNING THE AMOUNT OF SIXTY FOUR THOUSAND SEVEN HUNDRED SEVENTY PESOS AND NINETEEN CENTAVOS (PHP64,770.19) TAKEN FROM PERSONAL SERVICES SAVINGS TO AUGMENT FUND FOR MID-YEAR AND YEAR-END BONUS
