RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 04-2017 OF BARANGAY SAN FRANCISCO ENTITLED REALIGNING THE AMOUNT OF THIRTY EIGHT THOUSAND FIVE HUNDRED THIRTY THREE PESOS AND NINE CENTAVOS (PHP38,533.09) TAKEN FROM SUPPLY FOR BARANGAY TITLING, LATRINES AND MAINTENANCE OF SPRING WATER EXPENSES TO AUGMENT FUND FOR TRAVELLING EXPENSES OF BARANGAY SAN FRANCISCO, BULALACAO, ORIENTAL MINDORO






