EARNESTLY REQUESTING SIR NESTOR F. QUINSAY, JR., UNDERSECRETARY FOR PUBLIC SAFETY, DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) TO GRANT THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO WITH A MODERN FIRETRUCK, PERSONAL PROTECTIVE EQUIPMENTS (PPEs) AND OTHER AVAILABLE FIRE EQUIPMENTS

“WHEREAS, it is a Constitutional mandate that the State shall ensure security of its people against the damage of lives and properties brought by either natural or man made calamities such as the incidence of fire which brought sufferings, agony and emptiness;

“WHEREAS, the present Administration indispensably needs to protect its constituents from the anguish emanating from the occurrence of fire that it readily donated 400 sq.m. of lot where the Municipal Fire Station was erected in its effort to provide an office building of its own with better facilities and amenities to achieve a higher level of competitiveness in service;

“WHEREAS, equally important to fire truck is the provision of Personal Protective Equipments that shall defend the uses against health or safety risks and work. It includes safety helmets, gloves, eye protection, high visibility clothing, safety foot wear and safety harnesses and respiratory protective equipment;

“WHEREAS, being the Pro-Poor Municipality pursuant to Executive Order No. 370, the abovementioned fire truck and PPEs could only be achieve through the assistance of the Department of the Interior and Local Government; **Now, therefore, be it**

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request Sir Nestor F. Quinsay, Jr., Undersecretary for Public Safety, Department of the Interior and Local Government to grant the Municipality of Bulalacao, Oriental Mindoro with a modern fire truck, Personal Protective Equipments (PPEs) and other available fire equipments;


