"WHEREAS, the Doctor to the Barrio is the health program and strategy under the Department of Health-Center for Health Development (DOH-CHD) aimed to promote health consciousness in rural communities and to deliver medical services to remote and far-flung barangays;

"WHEREAS, it has been proven in the past that rural medical services rendered by the program "Doctor to the Barrio" was of big help in alleviating health conditions of rural communities giving them access to immediate medical needs and services;

"WHEREAS, the Municipality of Bulalacao is located in the southernmost tip of the Province of Oriental Mindoro whose residents is approximately composed of twenty percent hanunuo mangyans living in the hinterland who are prone to malaria, dengue and filariasis that various medical programs and activities should be introduced to arrest these contagious diseases which endangered the lives of our less fortunate brothers and sisters;




