EARNESTLY REQUESTING ATTY. MARTIN B. DELGRA III, CHAIRMAN, LAND TRANSPORTATION FRANCHISING AND REGULATORY BOARD (LTFRB) TO ALLOW THE DEL MONTE LAND TRANSPORT BUS COMPANY, INC. (DLTBCO) TO FILE THE NECESSARY APPLICATION FOR ISSUANCE OF CERTIFICATE OF PUBLIC CONVENIENCE TO OPERATE AN AIRCONDITIONED PUBLIC UTILITY BUS SERVICE VEHICLE COMPOSED OF FIFTY (50) UNITS PLYING FROM MARIKINA, CUBAO, LRT BUENDIA TO CALAPAN CITY, ORIENTAL AND OCCIDENTAL MINDORO ROUTES AND VICE VERSA

“WHEREAS, public transportation improves the quality of life in communities across the country by providing safe, efficient and economical service. It also serves as a vital component necessary for a healthy economy. Not only does public transit benefit the people who use it but it also benefits society as a whole;

“WHEREAS, as a result of preventive suspension of several public transportation vehicles which brought inconvenience and difficulties to the riding public, it is necessary to provide them a supplemental transportation service in order not to hamper their daily activities such as going to work, to school or for those doing business for their economic growth;

“WHEREAS, it is made known to this Body that Del Monte Land Transport Bus Company, Inc. (DLTBCO) is manifesting its intention to continue serving the riding public within the Provinces of Occidental and Oriental Mindoro so that this Sanggunian is expressing its strong support and therefore endorsing to the LTFRB to allow the company to file the necessary application for issuance of Certificate of Public Convenience to operate an airconditioned PUB service composed of fifty (50) units traversing the route mentioned herein; Now, therefore, be it

Delgra III, Chairman, Land Transportation Franchising and Regulatory Board (LTFRB) to allow the Del Monte Land Transport Bus Company, Inc. to file the necessary application for issuance of Certificate of Public Convenience to operate an airconditioned Public Utility Bus service vehicle composed of fifty (50) units plying from Marikina, Cubao, LRT Buendia to Calapan City, Oriental and Occidental Mindoro routes and vice versa;
