RESOLUTION NO. 20-02-165

RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2018-10-01, SANGGUNIANG KABATAAN ANNUAL BUDGET FOR FY 2019 OF BARANGAY POBLACION, BULALACAO, ORIENTAL MINDORO ENTITLED "AN ORDINANCE APPROPRIATING THE SUM OF FOUR HUNDRED THIRTY SEVEN THOUSAND EIGHT HUNDRED TWENTY ONE PESOS AND SEVENTY CENTAVOS (PHP437,821.70) TAKEN FROM TEN PERCENT (10%) OF THE GENERAL FUND OF THE BARANGAY, FOR 10% SANGGUNIANG KABATAAN FUND OF BARANGAY POBLACION, BULALACAO, ORIENTAL MINDORO" OPERATIVE IN ITS ENTIRETY

"WHEREAS, Section 57 and Section 447 par (li) empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

"WHEREAS, Section 329 of the same law states that ten percent (10%) of the general fund of the barangay shall be set aside for the Sangguniang Kabataan and use of such fund shall be in accordance with the Annual Barangay Youth Investment Program and in compliance with the provisions of RA 10742 or the SK Reform Act of 2015;

"WHEREAS, the Sangguniang Kabataan Annual Budget for FY 2019 of Barangay Poblacion was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on February 10, 2020 and was found to be consistent with pertinent laws, rules and regulations;

"WHEREAS, Sangguniang Kabataan of Barangay Poblacion, Bulalacao, Oriental Mindoro is likewise advised to strictly follow the recommendations of the Local Finance Committee as reflected in the review letter attached herewith;


"WHEREAS, it is therefore understood that disbursement of appropriation shall be guided by existing rules and regulations of Commission on Audit and all other government agencies, Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED To: Declare the Appropriation Ordinance No. 2018-10-01, Sangguniang Kabataan Annual Budget for FY 2019 of Barangay Poblacion, Bulalacao, Oriental Mindoro entitled "An ordinance approving the sum of four hundred thirty seven thousand eight hundred twenty one pesos and seventy centavos (PhP437,821.70) taken from ten percent (10%) Sangguniang Kabataan Fund of Barangay Poblacion, Bulalacao, Oriental Mindoro" **OPERATIVE IN ITS ENTIRETY;**


