RESOLUTION NO. 18-03-053

EARNESTLY REQUESTING THE COMMUNITY ENVIRONMENT AND NATURAL RESOURCES OFFICE (CENRO) TO CONDUCT SITE VERIFICATION AND INSPECTION OF THE SALVAGE ZONE AND FORESHORE LEASE AREAS ADJACENT TO THE MUNICIPAL CEMETERY AND THE LOTS OCCUPIED BY THE BUREAU OF FIRE PROTECTION AND OTHER BUILDING BEING CONSTRUCTED BY THE LOCAL GOVERNMENT UNIT OF BULALACAO COVERED UNDER TCT NO. 064-2011001761 WHICH SHALL SERVE AS A REFERENCE FOR THE FORESHORE LEASE APPLICATION (FLA) OF LGU BULALACAO OVER THOSE AREAS

"WHEREAS, The Philippine Fisheries Code of 1998 defines the term "foreshore" as a string of land margining a body of water; the part of the seashore between the low water line usually as the seaward margin of a low tide terrace and the upper limit of wave wash at high tide usually marked by a beach scarp or berm;

"WHEREAS, Section 3 (i) of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that the LGUs shall share with the national government the responsibility in the management and maintenance of ecological balance within their territorial jurisdiction subject to the provisions of this code and national policies;

"WHEREAS, the foreshore area is one area where rapid development is taking place. The sprouting of beach resorts and hotels along coastlines, the establishment of wharves and ports, the reclamation projects to accommodate residential, commercial and industrial estates are among the many activities now going on in the Philippine Foreshore Areas so that the Local Government Unit takes an active role in foreshore management;

"WHEREAS, site verification and inspection of the salvage zones and foreshore areas under TCT No. 064-2011001761 located in Barangay Poblacion, Bulalacao, Oriental Mindoro is important for it will serve as a reference for the LGU Bulalacao to take necessary actions over those areas for proper management and maintenance; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED To: Earnestly request the Community Environment and Natural Resources Office (CENRO) to conduct site verification and inspection of the salvage zone and foreshore lease areas adjacent to the municipal cemetery and the lots occupied by the Bureau of Fire Protection and other building being constructed by the Local Government Unit of Bulalacao covered under TCT No. 064-2011001761 which shall serve as a reference for the foreshore lease application (FLA) of LGU Bulalacao over those areas;
