### RESOLUTION NO. 18-02-043

RESOLUTION GRANTING GRATUITY PAY IN THE AMOUNT OF TWO THOUSAND PESOS (PHP2,000.00) TAKEN FROM CY 2017 BUDGET SURPLUS FOR EACH WORKER HIRED BY THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO IN JOB ORDER OR CONTRACT OF SERVICE BASIS PURSUANT TO ADMINISTRATIVE ORDER NO. 2, SERIES OF 2017 ISSUED BY PRESIDENT RODRIGO ROA DUTERTE

**"WHEREAS**, the Civil Service Commission allows the hiring of services of job order workers and contract of service workers to ensure to continuous and efficient delivery of government programs and activities such as in the implementation of projects requiring personnel with skills or expertise not available in the agency;

**"WHEREAS**, the Local Government Unit of Bulalacao, Oriental Mindoro is a Third Class Municipality with limited funds that it could not readily create permanent plantilla positions so that hiring of job order workers and contract of service workers that shall serve as support staff towards the best and effective delivery of basic social services to its constituents is the most practical strategy;

**"WHEREAS**, unlike permanent employee, job order and contract of service workers do not enjoy government benefits such as mid-year and year-end bonuses, performance bonus and personnel economic relief allowance (PERA), granting a gratuity pay is a well-deserved recognition of their hard work. Now, therefore, be it


