RESOLUTION NO. 19-01-023

RESOLUTION SEEKING INFORMATION AND VERIFICATION FROM THE DEPARTMENT OF TRANSPORTATION THE OPENING AND SUBSEQUENTLY OPERATION OF BATANGAS TO CATICLAN AND VICE VERSA ROUTE TAKING INTO CONSIDERATION THAT RORO PORTS IN ROXAS AND BULALACAO, BOTH IN THE PROVINCE OF ORIENTAL MINDORO HAVE THE SAME AND ONLY ROUTE

“WHEREAS, the Department of Transportation is the primary policy, planning, programming, coordinating, implementing and administrative entity of the executive branch of the government on the promotion, development and regulation of a dependable and coordinated network of transportation, as well as in the fast, safe, efficient and reliable transportation services;

“WHEREAS, the Philippine Nautical Highway System, also the Road Roll-on/Roll-off Terminal System or simply the RoRo System, is an integrated network of highway and vehicular ferry routes which forms the backbone of a nationwide vehicle transport system in the Philippines. It is a system of roads and ports developed by the Philippine government to connect the major islands of Luzon, the Visayas and Mindanao. The 919 kilometer nautical highway was opened to the public on April 12, 2003 as the Strong Republic Nautical Highway (SRNH);

“WHEREAS, it is noted that the travel time of ship from Batangas to Caticlan takes a minimum of twelve (12) hours, much longer compared to the travel time of ship from Roxas port to Caticlan which is five (5) hours, while Bulalacao, Oriental Mindoro to Caticlan takes only three (3) hours;

“WHEREAS, the Province of Oriental Mindoro was included in the Strong Republic Nautical Highway Program of President Gloria Macapagal Arroyo because it connects the Southern Tagalog region to Visayas and Mindanao that travelling time is made short and easier;

“WHEREAS, the opening of routes of Batangas to Caticlan affects the operation of Fastcat in Bulalacao, Oriental Mindoro, less passenger and cargo trucks are observed at present, declining the economic activities of Bulalacao ro-ro port; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Seek information and verification from the Department of Transportation the opening and subsequently operation of Batangas to Caticlan and vice versa route taking into consideration that ro-ro ports in Roxas and Bulalacao, both in the Province of Oriental Mindoro have the same and only route;

RESOLVED FURTHER, To: Send copies of this Resolution to the Maritime Industry Authority (MARINA) and Philippine Ports Authority (PPA) for their information and reference;
