“WHEREAS, to realize the objective of this years celebration, the Municipal Civil Registry Office, Municipality of Bulalacao, Oriental Mindoro in cooperation with the Office of the Municipal Mayor and the Office of the Sangguniang Bayan implemented various programs and activities such as information and education campaign, mobile registration and the kasalang bayan composed of 187 couples where 100 of them belong to the hanunuo group and 87 are christians;
