EARNESTLY REQUESTING THE GOVERNMENT SERVICE INSURANCE SYSTEM (GSIS) THRU ITS ACTING PRESIDENT AND GENERAL MANAGER, SIR ROLANDO I. MACASAET TO INCLUDE ELECTED LOCAL OFFICIALS OF THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO TO AVAIL THE GSIS FINANCIAL ASSISTANCE LOAN (GFAL) II

"WHEREAS, in order to improve the financial capability of GSIS members, provide an affordable loan package by enabling GSIS members to refinance their outstanding loans with lending institutions through the GSIS and to improve the collection efficiency of the GSIS; the GSIS launched the GSIS Financial Assistance Loan (GFAL) II Program to be extended to agencies willing to execute a Memorandum of Agreement with the GSIS;






