RESOLUTION FAVORABLY RECOMMENDING FOR IMMEDIATE APPROVAL OF THE APPLICATION OF DEL MONTE LAND TRANSPORT BUS COMPANY, INC. (DLTBCO) FOR THE ISSUANCE OF NEW CERTIFICATE OF PUBLIC CONVENIENCE TO OPERATE PUBLIC UTILITY BUS (PUB) IN DEVELOPMENTAL INTRA-PROVINCIAL ROUTES IN THE PROVINCE OF ORIENTAL MINDORO SUBMITTED BEFORE THE OFFICE OF THE LAND TRANSPORTATION FRANCHISING AND REGULATORY BOARD (LTFRB), REGION IV-MIMAROPA

"WHEREAS, in adherence to the consensus of the Provinces of Oriental and Occidental Mindoro in the inadequacy of public utility vehicles, a Transport Summit was held on May 8, 2018 where the Office of the Undersecretary for Road Transport and Infrastructure recommended additional routes for UV Express Vehicle and for Minibus or Bus Services to fill-up the deficiency;

"WHEREAS, the recommendation of the Road Transport and Infrastructure thru Undersecretary Thomas M. Orbos to the LTFRB was positively replied through the passing of Board Resolution No 053, series of 2018 entitled "Opening of applications for the issuance of new CPC to operate UV Express Vehicle and PUB Mini Service in developmental intra-provincial routes in Oriental Mindoro and opening of applications for appropriation in identified PUJ routes";












