EARNESTLY REQUESTING PRESIDENT RODRIGO ROA DUTERTE, REPUBLIC OF THE PHILIPPINES TO KINDLY INSTRUCT THE LAND TRANSPORTATION FRANCHISING AND REGULATORY BOARD (LTFRB) TO TAKE IMMEDIATE ACTION ON APPLICATIONS FOR FRANCHISE OF VANS OPERATING WITHIN THE PROVINCES OF OCCIDENTAL AND ORIENTAL MINDORO

“WHEREAS, the Land Transportation Franchising and Regulatory Board also known as LTFRB is an agency under the Department of Transportation responsible for promulgating, administering, enforcing and monitoring compliance of policies, laws and regulations of public land transportation services including the grant of franchise to public transportation vehicles operating within a certain routes;

“WHEREAS, the Provinces of Occidental and Oriental Mindoro suffered *difficulties and inconvenience in commuting for only few vans and buses with franchise to operate are allowed where most of the passengers are forced to hire tricycles and single motorcycles at high rates just to go home, this situation also hampered the social and economic activities of small-scale businessmen resulting to low family income which might further affects the education of the children;*

“WHEREAS, it is learned that those public transportation vehicles such as vans operating within the two (2) provinces have pending applications for franchise in the LTFRB however, up to this time it is not yet acted upon by the agency due to unknown reasons so that, it is firmly believed that through the intervention of the President of the Republic of the Philippines, those applications be approved so that vans may legally operate within the prescribed routes; Now, therefore, be it


RESOLVED AS IT IS HEREBY RESOLVED To: Earnestly request President Rodrigo Roa Duterte, Republic of the Philippines to kindly instruct the Land Transportation Franchising and Regulatory Board (LTFRB) to take immediate action on applications for franchise of vans operating within the Provinces of Occidental and Oriental Mindoro;
