RESOLUTION NO. 18-01-001

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO MEET AND DISCUSS WITH THE NATIONAL GOVERNMENT (NG), ITS AGENCIES AND INSTRUMENTALITIES, THE SPECIFIC TERMS OF THE IMPLEMENTATION OF THE DECISION OF THE SUPREME COURT IN THE PETITION FILED BY THEN CONGRESSMAN MANDANAS, ET AL. DOCKETED AS SC-G.R 199802 WITH AUTHORITY TO DELEGATE REPRESENTATION TO LEGAL ENTITIES ACKNOWLEDGED AND RECOGNIZED BY THE NATIONAL GOVERNMENT FOR THE SAID PURPOSE

“WHEREAS, on 10 January 2012, then Congressman Hermilano I. Mandanas as lead petitioner and in representation of local government units filed a petition in the Supreme Court docketed as SC-G.R. No. 199802 against the NG seeking the automatic release of the LGUs full share of the government taxes known as the Internal Revenue Allotment (IRA) as provided for in the Constitution and Laws;

“WHEREAS, the NG is in the process of negotiating the full implementation of the decision of the Supreme Court in the said case;

“WHEREAS, there is a need for the Municipality of Bulalacao, Province of Oriental Mindoro for representation with the NG in the full implementation of the decision and eventual release of the IRA;

“WHEREAS, the eventual release of the said IRA subject of the aforementioned case will enable the LGU to hasten delivery of much needed services to its constituents such as Health Care, Education, Livelihood and Environmental Protection, Housing, Roads and Bridges, Education, Safe Drinking Water, Disaster Preparedness, etc.;











"WHEREAS, the full and automatic release of the above-mentioned IRA will strengthen Local Autonomy and prepare the LGU toward Federalism;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, That: Honorable Ernilo C. Villas, Municipal Mayor is hereby appointed and authorized in behalf of the Municipality of Bulalacao, Province of Oriental Mindoro to meet, study and discuss with the NG, its agencies and instrumentalities, the specific terms of implementation of the decision of the Supreme Court;


