**EARNESTLY REQUESTING THE PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO THROUGH GOVERNOR HUMERLITO "BONZ" A. DOLOR TO FACILITATE THE DECLARATION AS PROVINCIAL ROAD, THE ROADS TRAVERSING FROM SITIOS ALIMANGO, BATING, HINAGDANAN, BALWA IN BARANGAY MILAGROSA, BULALACAO, ORIENTAL MINDORO TO SITIO KALACHUCHI, BARANGAY ALIBOG, MAGSAYSAY, OCCIDENTAL MINDORO AND APPROPRIATING FUNDS THEREOF**

**"WHEREAS**, provincial roads are those roads connecting one municipality to another, normally terminating at public plazas; all roads extending from a municipality or from a provincial or national road to a public wharf or railway station; and any other road to be designated as such by the Sangguniang Panlalawigan;

**"WHEREAS**, roads are of vital importance in order to make a nation grow and develop. It provides access to employment, social, health and education services which makes a road network crucial in fighting against poverty. Roads open up more areas and stimulate economic and social development;


**"WHEREAS**, the main characteristic of the construction of roads is connecting people from different parts of the country in order to ensure their participation in all aspects of life together with the free movement of goods, services and people;

"WHEREAS, connecting roads at the abovementioned areas would promote unity and cooperation between the provinces of Oriental and Occidental Mindoro, enhance friendship and partnership in the conduct of trade and commerce that shall redound to social and economic benefits of the two Provinces; Now, therefore, be it


RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Provincial Government of Oriental Mindoro through Governor Humerlito "Bonz" A. Dolor to facilitate the declaration as provincial road, the roads traversing from Sitios Alimango, Bating, Hinagdanan, Balwa in Barangay Milagrosa, Bulalacao, Oriental Mindoro to Sitio Kalachuchi, Barangay Alibog, Magsaysay, Occidental Mindoro and appropriating funds thereof;
