RESOLUTION REQUESTING THE MALAMPAYA FOUNDATION INC. TO SPONSOR SITIO ELECTRIFICATION PROJECT IN GEOGRAPHICALLY ISOLATED, DEPRESSED AND MANGYAN AREAS IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions;

"WHEREAS, for over the past decades, our Government has always been prioritizing the rural electrification, it strongly believes that the provision of electric services will produce more opportunities to improve the socio-economic growth of the marginalized sectors, and it will have a greater access to basic services and better infrastructure for rural development;

"WHEREAS, pursuant to Executive Order No. 370 the Municipality of Bulalacao is considered as a 3rd class municipality hounded with financial constraints, it is located at the southernmost tip of the Province of Oriental Mindoro and according to the 2015 census it has a population of 39,107 people where almost 25 percent of it are indigenous people called Hanunuo-Mangyans;

"WHEREAS, Bulalacao is pursuing to be an agro-eco-tourism destination in the Province of Oriental Mindoro, to have the sitios in geographically isolated and depressed areas in this municipality get electrified, it would not only give ease and comfort but it would also instill the minds of every Bulalacaonon especially the Mangyans that no one is left behind in the progress of the said municipality;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, To; request the Malampaya Foundation Inc. to sponsor Sitio Electrification Project in geographically isolated, depressed and Mangyan areas in Bulalacao, Oriental Mindoro.
