

RESOLUTION NO. 67
ORDINANCE NO. 18

AN ORDINANCE REQUIRING ALL PERSONS WHO DESIRE TO FENCE OR ENCLOSE THEIR LOT OR YARD TO SECURE MAYOR'S PERMIT BEFORE STARTING THE WORK

WHEREAS, it has come to the attention and knowledge of this Body that some disputes among neighbors arise from the overlapping of fence, or enclosures made;

WHEREAS, in order to avoid further occurrences of such disputes the Sangguniang Bayan of Bulalacao, Oriental Mindoro in session assembled Ordains:

T H A T

SECTION 1. Any person desiring to construct fence or enclosures on their lot or yard must secure a Mayor's Permit before construction be started;

SECTION 2. Permit to construct fences or enclosures shall be granted only after showing letter of agreement between him and among owners of adjacent lots or yards allowing him to construct the said fence or enclosure;

SECTION 3. That the area to be fenced or enclosed must be in conformity with the area appearing in the Tax Declaration issued by the Municipal Assessor;

SECTION 4. The lot shall be inspected by the Municipal Assessor or his duly authorized representative before the construction of fence of enclosures be started;

SECTION 5. There shall be collected a Permit fee of ₱25.00 and Inspection fee of ₱10.00 which shall be paid to the Municipal Treasurer upon application for the said Permit;

SECTION 6. Any person found violating any provision of this Ordinance shall suffer a fine of not less than Two Hundred Pesos (₱200.00) but not more than Two Thousand and Five Hundred Pesos (₱2,500.00) or an imprisonment of not less than one (1) month but not more than six (6) months or both such fine and imprisonment at the discretion of the Court;

SECTION 7. All Ordinances inconsistent with the provisions of this Ordinance is hereby repealed or modified accordingly;

SECTION 8. This Ordinance shall take effect ten (10) days after its passage

RESOLVED FURTHER, to submit copies of this Resolution and Municipal Ordinance to PNP, Bulalacao, Oriental Mdo., Bulalacao Station, Municipal Assessor's Office, Treasurer's Office and Mayor's Office for their information and proper action.
