ORDINANCE NO. 14

AN ORDINANCE SETTING CRITERIA AND REQUIREMENTS FOR THE ACCREDITATION OF PEOPLE'S ORGANIZATION (PO's) AND NON-GOVERNMENTAL ORGANIZATION (NGO's) FOR MEMBERSHIP IN THE MUNICIPAL DEVELOPMENT COUNCIL (MDC)

BE IT ENACTED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro to set the following criteria and requirements for People's Organization (PO's) and Non-Governmental Organization (NGO's) before accreditation for membership in Municipal Development Council (MDC) be made;

SECTION 1. The following criteria and requirements must be fulfilled by any People's Organization (PO's) or Non-Governmental Organization (NGO) before accreditation for membership be made;

1. Duly approved Board Resolution of the PO's and NGO's;
2. Certificate of registration with either the Securities and Exchange Commission (SEC), Cooperative Development Agency (CDA), Department of Labor and Employment (DOLE), Department of Social Welfare and Development (DSWD), or any recognized National Government Agency (NGA);
3. List of Officers;
4. List of Accomplishments;
5. Financial data of the Organization;
6. Organizational purpose and objectives include community organization and development institution-building, local enterprise development, capability-building and seminar development objectives and considerations;
7. Community-based with project development and information track record of at least one year;
8. Reability as evidenced by the preparation of Annual Reports and conduct of annual meeting duly certified by the Board Secretary of the organization;
9. In the case of Prequalification, Bids and Awards Committee (PPBAC), the organization or any of its members shall have no conflict of interest in the awarding of infrastructure or other projects;
10. Registration fee amounting to P 10.00 which shall be paid to the Municipal Treasurer upon application for registration.

SECTION 2. DEFINITION. As used in the Ordinance, the terms " non-governmental organizations and People's organization " refer to and include those organizations, initiated or organized by private persons and not upon the initiative of government agencies through its personnel which include social, civic, religious, or sports associations as well as clubs, foundations fraternities and similar organizations.

SECTION 3. Failure to meet or submit the foregoing criteria and requirements is a ground for the denial of accreditation;


SECTION 4. This Ordinance taken effect ten (10) days after its passage;

RESOLVED FURTHER, to submit copies of this Resolution and Municipal Ordinance to the Municipal Planning and Development Office, Engineer Chiquita C. Jano, Bulalacao, Oriental Mindoro for her information and reference.

RESOLVED FURTHERMORE, that the Municipal Planning and Development Officer shall receive and review the submitted requirements of the applying organizations.
