

RESOLUTION NO. 48
ORDINANCE NO. 11

AN ORDINANCE REQUIRING THE BUYERS OF LAPU LAPU FRY BANGUS FRY OR KAWAG KAWAG OR FRY OF OTHER SPECIES OF FISH PROPAGATION TO SECURE MAYOR'S PERMIT, BUSINESS LICENSE, AND OTHER NECESSARY PERMITS BEFORE OPERATION BE MADE

WHEREAS, Articles X, Section 5 of 1987 Constitution of the Republic of the Philippine provides that: "Each Local Government Unit shall have the power to create its own source of revenues and to levy taxes, and charges. . . Such taxes, fees and charges shall accrue exclusively to the Local Government;

WHEREAS, the New Tax Ordinance of Bulalacao, Oriental Mindoro, Chapter 111, Art. A. Section 3A 01 further provided that: There shall be collected an annual fee for the issuance of a Mayor's Permit to every person, natural or juridical, for the operation of any business or service establishments, conduct of any trade activity, pursuit for any commercial undertaking and practice of occupation or calling within this Municipality;

WHEREAS, the fees that shall be collected from the buyers of Lapu-Lapu fry Bangus fry and fry of other species of fish propagation shall increase the Municipal Revenue;

NOW THEREFORE:

BE, it enacted by the Sangguniang Bayan of Bulalacao, Oriental Mindoro assembled;

SECTION 1. All buyers of Lapu Lapu fry Bangus fry, or Kawag-Kawag, or fry of other species of fish propagation must secure first the Mayor's Permit, Business License and other necessary Permits before they operate;

SECTION 2. There shall be collected from every buyers of Lapu Lapu fry Bangus fry of Kawag Kawag or fry of other species of fish propagation the following fees:

a) Mayor's Permit	₱ 250.00
b) Application Fee	110.00
c) Business Tax	1,000.00
d) Medical Fee	20.00
e) Sanitary Fee	20.00
f) Service Charge	20.00
T O T A L	₱ 1,420.00

SECTION 3. TIME AND MANNER OF PAYMENT. The fee imposed herein shall be paid to the Municipal Treasurer upon application for a Mayor's Permit to buy the aforementioned products;

SECTION 4. PENALTY. Any violation of the provisions of this Ordinance shall be punished by a fine of not less than One Thousand Pesos (₱1,000.00) but not more than Two Thousand and Five Hundred Pesos (₱2,500.00) or imprisonment of not less than one (1) month but not more than six (6) months, or both such fine and imprisonment at the discretion of the Court;

SECTION 5. REPEALING CLAUSE. All Ordinances inconsistent with the provisions of this Ordinances are hereby repealed or modified accordingly;


SECTION 6. This Ordinance shall take effect after its passage;
