

RESOLUTION NO. 36
ORDINANCE NO. 7

AN ORDINANCE DESIGNATING THE OPEN AREA WEST OF THE PUBLIC MARKET AS PERMANENT PARKING AREA FOR ALL TYPES OF VEHICLES, PAYMENT OF THE CORRESPONDING FEES AND IMPOSING FINES AND IMPRISONMENT FOR EVERY VIOLATORS THEREOF

WHEREAS, Resolution No. 11, Ordinance No. 3, series of 1978 declared F. Atienza St., Templanza St., and Salas St., as one way to all vehicles entering and leaving this Municipality;

WHEREAS, parking along both sides of F. Atienza St., Templanza St., and Salas St., obstructs the flow of traffic the width of these streets;

WHEREAS, the Sangguniang Bayan has observed the rampant practice of many drivers parking their vehicles along both sides of F. Atienza St., Templanza St., and Salas At., thereby ~~permanently~~ impeding the orderly flow of traffic;

WHEREAS, in order to stop this practice and to facilitate the flow of traffic, the Sangguniang Bayan by virtue of the power of Republic Act. 1760, be it enacted by the Sangguniang Bayan of Bulalacao, Oriental Mindoro;

T H A T

SECTION 1. The portion of the open area west of the Public Market of Bulalacao is hereby designated as Permanent Parking Space for all types of vehicles;

SECTION 2. FEES AND CHARGES. The fees to be collected from each parking shall be:

- a) Buses ₱ 10.00 per parking
- b) Jeepneys 5.00 " "
- c) Cargo trucks 30.00 " "

SECTION 3. All collections fees and charges shall be done by the Municipal Treasurer or his duly authorized representatives;

SECTION 4. Parking along both sides F. Atienza St., Templanza St., and Salas and Contreras St., is strictly prohibited for all types of vehicles;

SECTION 5. PUNISHMENT. Any person found violating our provisions with this Ordinance shall be punished by:

- a) A fine of Five Hundred Pesos (₱500.00) or an imprisonment of Fifty (50) days or both at the discretion of the Court; for the first offense;
- b) A fine of One Thousand Pesos and Five Hundred (₱1,500.00) or an imprisonment of One Hundred (100) days or both at the discretion of the Court, for the second offense;
- c) A fine of Two Thousand Pesos and Five Hundred (₱2,500.00) or an imprisonment of One Hundred Fifty (150) days or both at the discretion of the Court, for the third time and habitual offenders.


SECTION 6. REPEALING CLAUSE. All Ordinances inconsistent with this Ordinance are hereby repealed or modified accordingly;

SECTION 7. EFFECTIVITY. This Ordinance takes effect on (10) days immediately after its passage;

RESOLVED FURTHER, that copies of this Ordinance be forwarded to the Philippine National Police (PNP) Bulalacao, Oriental Mindoro for strict implementation.
