**ORDINANCE NO. 14-12-143**

**AN ORDINANCE GRANTING A FRANCHISE TO ESTABLISH, MAINTAIN, PROMOTE AND OPERATE A COCKPIT OR COCKFIGHTING ACTIVITY IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** Subject to the provisions of laws, orders or issuances, qualified grantee is hereby granted a franchise to establish, maintain, promote and operate a cockpit or cockfighting activity for the period of eight (8) years from the date of effectivity of this ordinance unless sooner revoked or cancelled in consideration of the franchise and rights herein granted. The grantee shall pay the amount of Forty Thousand Pesos (PhP40,000.00) as Franchise Fee.

**SEC. 2.** The grantee shall begin to operate after he had secured an annual permit to operate a cockpit or cockfighting activity in this Municipality.

**SEC. 3.** The regular cockfighting activity can only be held in the licensed cockpit or designated cockpit arena during Sundays. Special cockfighting or game cockfighting like derby, local fiestas and legal holidays and such other cockfighting activities may be held only upon securing a special permit however; such permit should not be more than three (3) days.

**SEC. 4.** Holding a gamecock or cockfighting activity is not allowed during Local and National Election days, Referendum, Holy Thursday and Good Friday within the Municipality of Bulalacao, Province of Oriental Mindoro.

**SEC. 5.** There shall be collected the following regulatory fees from cockpit operators, owners, licensee fee and cockpit personnel as cited in the Municipal Tax Code for the regular cockfighting activity:

1. Application fee	-	Php 100.00
2. Secretary's fee	-	100.00
3. Ocular Inspection fee	-	100.00
4. Registration fee	-	25,000.00
5. Licensee fee	-	25,000.00
6. Mayor's permit fee	-	1,500.00
7. Garbage fee	-	50.00

**B. For the Personnel of cockpit to be paid annually:**

1. Promoter, General Manager permit fee -	200.00
2. Referee/sentenciador permit fee -	200.00
3. Bet manager/kasador permit fee -	200.00
4. Bet taker/kristo liamador permit fee -	200.00
5. Gaffer/Mananari permit fee -	100.00

**C. For the Special Gamecockfighting activity:**

1. Licensee for promoters fee -	2,000.00
2. Special permit fee -	2,000.00
3. Registered Derby Match maker fee -	2,000.00
4. Fastest kill fee -	2,000.00
5. 2-cock derby fee -	2,000.00
6. 3-cock derby fee -	3,000.00
7. 4-cock derby fee -	4,000.00
8. 5-cock derby fee -	5,000.00
9. 6-cock derby fee -	6,000.00
10. 7-cock derby fee -	7,000.00

**D. Other fees for Special cock fight. Payment shall be collected every fight by the Municipal Treasurer or his duly authorized representatives.**

1. Bet 2,000.00 -	100.00
2. Bet 3,000.00 to 5,000.00 -	100.00
3. Bet 6,000.00 to 10,000.00 -	100.00
4. Bet 10,000.00 to 20,000.00 -	200.00
5. Bet 30,000.00 to 40,000.00 -	200.00
6. Bet over 50,000.00 and above -	200.00

**SEC. 6.** The permit for cockpit personnel shall be paid before they participate in a cockfighting and pay annually upon renewal of the permit on the birth month of the permittee. Only duly registered and licensed personnel shall take part in all kinds of cockfights held in this Municipality. No operator or owner of a cockpit shall employ or allow to participate in a cockfighting activity. Any of the above mentioned personnel unless he has registered and paid the fee herein required.

**SEC. 7.** The franchisee is obliged to construct a cockpit arena in accordance with the specification and requirements set forth by Presidential Decree No. 449 otherwise known as the Cockfighting Law of 1974.

**SEC. 8.** The provision of PD 449 and PD 1802, Creating the Philippine Gamefowl Commission and such other pertinent laws shall apply to all matters regarding the operation of cockpits in this Municipality.

**SEC. 9.** Violation of any provision of this Ordinance shall have the following penalties:

- First Offense - Two weeks suspension with penalty of PhP 1,000.00
- Second Offense- One month suspension with penalty of PhP 2,000.00
- Third Offense - Revocation of franchise with penalty of PhP 2,500.00 or both such fine and imprisonment upon the discretion of the Court.

**SEC. 10.** All ordinances, rules and regulations or part thereof which provisions are in conflict with or contrary to the provision of this Ordinance are hereby amended or modified accordingly.

**SEC. 11.** This Ordinance shall take effect upon approval of the Sangguniang Bayan of Bulalacao, Oriental Mindoro and after copy of this has been posted at least three (3) conspicuous places in the Municipality.


