SPECIAL ORDINANCE NO. 14-09-37

SPECIAL ORDINANCE TEMPORARY CLOSING AND SUBSEQUENTLY OPENING TWO-WAY TRAFFIC OF CERTAIN ROAD PORTIONS IN BARANGAYS POBLACION AND CAMPAASAN IN CONNECTION WITH THE HOSTING OF BULALACAO OF THE 22ND ANNIVERSARY OF COUPLES FOR CHRIST-ORIENTAL MINDORO ON SEPTEMBER 20, 2014

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. The following road portions located at Barangays Poblacion and Campaasan, this Municipality are hereby declared to be temporarily closed during the celebration of the 22nd Anniversary of Couples for Christ-Oriental Mindoro on September 20, 2014; to wit:

- a. A. Salas St. (from Nachor S. Cabagay to Felicidad S. Acosta Residences)
- b. J. Templanza St. (Anabelle G. Feranil Bldg. to Dolores S. Bago Residences)
- c. R. Bago St. (South Drive Restaurant to Bulalacao Bakeshop)
- d. F. Atienza St. (Cristeta Paz to Richard Telesforo Residences)
- e. G. Contreras St. (The Salvation Army to Catholic Church)

SEC. 2. The rest of F. Atienza St. shall be opened for two-way traffic only during the celebration.

SEC. 4. The Philippine National Police and Barangay Police of Poblacion and Campaasan shall enforce this Special Ordinance.


SEC. 5. This Special Ordinance shall take effect immediately.






