SPECIAL ORDINANCE NO. 11-01-04

SPECIAL ORDINANCE RATIFYING THE CONTRACT ENTERED INTO BY AND BETWEEN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO REPRESENTED BY MAYOR ERNILO C. VILLAS WITH MR. BENJAMIN H. SALAS FOR THE RENTAL OF THE WATERSHED OWNED BY THE LATTER SITUATED AT SITIO TULALE, BARANGAY POBLACION WHICH SUFFICIENTLY SUPPLY WATER IN BARANGAYS POBLACION AND CAMPAASAN IN THE AMOUNT OF SIX THOUSAND PESOS (PHP6,000.00) PER MONTH

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. The Contract entered into by and between the Municipality of Bulalacao, Province of Oriental Mindoro represented by Mayor Ernilo C. Villas with Mr. Benjamin H. Salas is hereby ratified and made for the rental of the watershed owned by the latter situated at Sitio Tulale, Barangay Poblacion which sufficiently supply water in Barangays Poblacion and Campaasan in the amount of Six Thousand Pesos (Php6,000.00) per month;

SEC. 2. This Special Ordinance shall take effect immediately.
