SPECIAL ORDINANCE NO. 12-03-10

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A CONTRACT OF SERVICE WITH ACERON AND ACERON LAW OFFICE REPRESENTED BY ATTY. EDGARDO C. ACERON ENGAGING HIS SERVICES AS LEGAL CONSULTANT FOR THE PURPOSE OF DEFENDING THE RIGHTS OF THE LGU OF BULALACAO INCLUDING ITS OFFICIALS AND EMPLOYEES IN THE PERFORMANCE OF THEIR DUTIES AND FUNCTIONS STARTING JANUARY 1, 2012 TO DECEMBER 31, 2012 AND RATIFYING THIS CONTRACT OF SERVICE

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. The Municipal Mayor, Engr. Ernilo C. Villas is hereby authorized to enter into a Contract of Service with Aceron and Aceron Law Office represented by its Senior Partner, Atty. Edgardo C. Aceron engaging his services as Legal Consultant for the purpose of defending the rights of the LGU of Bulalacao including its officials and employees in the performance of their duties and functions starting January 1, 2012 to December 31, 2012 and this Contract of Service is hereby ratified;

SEC. 2. This Special Ordinance shall take effect immediately.


