ORDINANCE NO. 11-12-122

AMENDING ORDINANCE NO. 11-08-113, FIXING THE REVISED RATE OF WATER CONSUMPTION WITHIN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

SPONSOR: Councilor Juan L. Salas, Sr.

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. Section 1 and Section 2 of Ordinance No. 11-08-113, Fixing the revised rate of water consumption within the Municipality of Bulalacao, Province of Oriental Mindoro is hereby amended to read as follows:

"Section 1. The rate of water consumption within the Municipality of Bulalacao, Province of Oriental Mindoro is hereby fixed in the following manner;

- i. Minimum rate at minimum water consumption - Php30.00/6 cu.m.
- ii. For every cubic meter in excess of 6 cu. m. - 10.00/cu.m.

SEC. 2. The reconnection fee is likewise fixed at Two Hundred Pesos (Php200.00)."
