**ORDINANCE NO. 15-03-145**

**AN ORDINANCE AMENDING SECTION 5J.01, ARTICLE J OF THE NEW REVENUE CODE OF 2004, REGISTRATION FEES ON FISHING BOATS AND MOTORBOATS**

**SPONSOR:** Councilor Edwin C. Aceron  
**CHAIRMAN:** Committee on Ways and Means

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro

**SECTION 1.** Article J of the new Revenue Code of 2004 is hereby amended by changing the words Registration fees into License fees and Section 5J.01 is likewise amended to be read as follows;

**“Section 5J.01. Imposition of Fees.** There shall be collected the following annual license fees from the owner of each fishing boat or motorboat of three (3) tons or less being operated in this municipality in the amount indicated in this Article; to wit:

- a. Motorized fishing boat or fishing boat  
two (2) tons but not more than three (3) tons - PhP 1,000.00
- b. Motorized fishing boat or fishing boat one (1) ton  
but not more than two (2) tons - 700.00
- c. Motorized fishing boat or fishing boat  
with less than one (1) tonnage - 500.00
- d. Renewal - 100.00

**SEC. 2.** This Ordinance shall take effect immediately.
