**SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE, REGIONAL FIELD UNIT IV-B REPRESENTED BY ITS REGIONAL DIRECTOR, ATTY. CIPRIANO G. SANTIAGO FOR GRANTING THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO WITH 1-UNIT OF RE FORD TRACTOR UNDER THE BUB PROJECTS OF THE NATIONAL GOVERNMENT**
