ORDINANCE NO. 16-12-169

ORDINANCE IMPOSING FEES FOR THE REGISTRATION OF PRIVATE BRAND AND REGISTRATION OF CATTLE, HORSE, MULE, DONKEY, AND CARABAO, AND OTHER RELATED FEES IN BULALACAO, ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. STATEMENT OF POLICY. It is a policy of the Local Government Unit of Bulalacao, Oriental Mindoro to regulate livestock industry in order to protect the public from any untoward incident that may pose dangers to animal ownership and health of people. It is also the policy of the agency to find ways and means to increase local revenue to support its programs and activities that redound to the benefit of the people.

SEC. 2. IMPOSITION OF FEES. The Municipal Treasury Office shall collect fees for the following:

a. Registration/Certificate of ownership per head	-	PhP 75.00
b. Registration/Certificate of transfer of ownership per head	-	100.00
c. Registration of private brand per piece	-	150.00
d. Branding fee per head	-	60.00
e. Inspection fee per head	-	20.00
f. Penalty for late registration per head	-	70.00
g. Permit fee to transport per head	-	20.00

If an animal is transferred more than once in a day, transfer fee shall be collected just once.

Imposition of related fees shall be guided by Accountable Forms No. 50 & 52.

SEC. 3. TIME AND MANNER OF PAYMENT. All fees mentioned herein shall be paid to the Municipal Treasury Office which shall issue official receipt upon actual receipt of cash payment. Payment shall be done prior to registration of animals and private brand. Permits shall be paid and secured at least five (5) working days before the transport of animals.

SEC. 4. ADMINISTRATIVE PROVISION. The owner is hereby required to register his/her one (1) year old animals with the Municipal Agriculture Office which shall maintain a registration book detailing information such as but not limited to registration number; name and address of the owner; official receipt number of payment; kind, color, age, brand and other identifying marks of the animals; and date of registration. Registration of more than two (2) years old animals shall be considered late and hence shall be charged with penalty for late registration.

The transfer of large animals, regardless of age, shall likewise be registered with the Municipal Agriculture Office. Entries in the animal transfer registry book shall include but not limited to, the names and addresses of owner and purchaser; original registration number with the name of Municipality or City to which the registration was made; transfer reference number; official receipt number of payment; purchase or transfer price; kind, color, age, brand, and other identifying marks of the animals and date of transfer.

The Municipal Agriculture Office shall also maintain brand registration book in order to record pertinent information like name and address of owner, brand design as much as practicable in actual size, official receipt number of payment, date of registration, among others.


All animal buy and sell agents shall secure occupational and business permits. The Office of the Municipal Mayor shall issue the permit to transport only upon presentation of proof of payment, ownership or transfer documents, occupational and business permits, and all other pertinent documents.


SEC. 5. PENALTY. Any violation of the provisions of this Ordinance shall be penalized by a fine of not less than One Thousand Pesos (PhP1,000.00) but not more than Five Thousand Pesos (PhP5,000.00) or imprisonment of not less than one (1) month but not more than six (6) months or both such fine and imprisonment at the discretion of the Court.


SEC. 6. REPEALING CLAUSE. Any Ordinances inconsistent with the provisions of this Ordinance is hereby repealed or modified accordingly.


