MUNICIPAL ORDINANCE NO. 20-12-280

AN ORDINANCE REQUIRING THE MANDATORY PHILHEALTH REGISTRATION OF ALL INDIVIDUALS AGED TWENTY ONE (21) YEARS OLD AND ABOVE AND THOSE INDIVIDUALS AGED TWENTY (20) YEARS OLD AND BELOW BUT WITH A CHILD OR CHILDREN RESIDING IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO RELATIVE TO THE PASSAGE OF REPUBLIC ACT NO. 11223 OTHERWISE KNOWN AS THE UNIVERSAL HEALTH CARE ACT

"WHEREAS, the Sangguniang Bayan of Bulalacao received a letter dated October 27, 2020 from the Philippine Health Insurance Corporation (PhilHealth), Local Health Insurance Office Oriental Mindoro, requesting to pass a municipal ordinance for the mandatory registration to the National Health Insurance Program (NHIP) of all individuals aged twenty one (21) years old and above and those individuals aged twenty (20) years old and below but with a child or children residing in the Municipality of Bulalacao, Province of Oriental Mindoro;

"WHEREAS, RA 11223 or the Universal Health Care Law provides every Filipino automatic PhilHealth coverage and immediate eligibility and all Filipinos requiring hospitalization are deemed eligible to avail PhilHealth benefits;

"WHEREAS, Section 8 of RA 11223 simplifies the PhilHealth membership categories into direct contributors for those who have the capacity to pay fully their PhilHealth contribution and indirect contributors for those whose PhilHealth premiums are subsidized by the National Government;

"WHEREAS, non-registration may be attributed to an individual's non-capacity to pay contributions, thus, Section 8 item 5 of the implementing rules and regulation of the UHC Law mandates PhilHealth to authorize the DSWD or the municipal social welfare and development officers of local government units (LGUs) to determine those who are financially capable to pay PhilHealth contributions or not;

NOW THEREFORE, be it ordained by the Sangguniang Bayan of Bulalacao, Oriental Mindoro, that:

Section 1. Statement of Policy. It is the policy of the Local Government Unit of Bulalacao (LGU of Bulalacao) to uphold, respect, and observe the specific provisions of R.A. 11223 or the Universal Health Care Law on providing every Filipino automatic PhilHealth coverage and immediate eligibility to avail PhilHealth benefits;

Section 2. Title. This Ordinance is entitled as stated and shall be also known as the "Sana All Member ng PhilHealth Ordinance of Bulalacao".

Section 3. Assessment. Thru the support and assistance of all barangay officials and barangay health workers, all unregistered individuals shall subject themselves to an assessment by the Municipal Social Welfare and Development Office (MSWDO) to determine financial capacity in order to identify their PhilHealth membership category, whether direct or indirect contributors;

Section 4. Registration. Individuals assessed to be financially incapable shall be registered as indirect contributors whose contributions shall be subsidized by the National Government while individuals assessed to be financially capable shall pay their contribution in accordance with the premium rates specified in Section 10 of RA 11223;

Section 5. Information Dissemination. The Municipal Health Office, MSWDO, Public Information Unit of the Office of the Municipal Mayor, and all Sangguniang Barangays shall conduct information, education, and communication activities regarding this Ordinance.

Section 6. Fund. The fund needed for the implementation of this ordinance shall be charged against appropriate expense under the Municipal Social Welfare and Development Office.

Section 7. Penalty. Any officer or employee who shall disregard or neglect the implementation of this Ordinance shall be administratively dealt with and such shall be a ground for suspension or dismissal subject to due process based on pertinent provisions of the Civil Service Laws and Rules and other laws and issuances. A job order or contract of service worker who shall be proven to have disregarded or neglected the implementation of this Ordinance shall be terminated.

Section 8. Repealing Clause. Any ordinance inconsistent with the provisions of this Ordinance is hereby repealed or modified accordingly.

Section 9. Separability Clause. If any provision of this Ordinance is declared invalid, the remainder or any provision hereof not affected thereby shall remain in force and effect. Higher laws or policies inconsistent with the provisions of this Ordinance shall prevail.


Section 10. Effectivity. This Ordinance shall take effect immediately after fifteen (15) days of posting in bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Local Government Unit of Bulalacao.






