

WHEREAS, the Municipality of Bulalacao is well-nigh to being an agro-eco-tourism destination in the Province of Oriental Mindoro that collaborative hard works from both government and private sectors are applied and gathered together to deliver the best positive outcome;

WHEREAS, the conduct of the Bulalacao Nights is a collaborative project of the Sangguniang Barangay of Poblacion, Bulalacao Municipal Police Station, Bulalacao Online Palengke, and the Local Government Unit of Bulalacao headed by the Tourism Office;

WHEREAS, the operation of Bulalacao Nights shall be located at the Bulalacao Bay Park, Barangay Poblacion, Bulalacao Oriental Mindoro;

WHEREAS, in view of the fact of the limited allotted fund for this project, there is a need to regulate the imposition of fees and charges to all vendors and stalls that will operate in the said event in order to optimize the utilization of funds and resources to augment the necessary operating expenses in the whole duration of Bulalacao Nights;

NOW, THEREFORE, BE IT ORDAINED, as it is hereby ordained by the Sangguniang Bayan of Bulalacao, Oriental Mindoro, that:

Section 1. Statement of Policy. It is the policy of the Local Government Unit of Bulalacao (LGU of Bulalacao) to provide an equitable and organized imposition of fees and charges in any events and activities to be conducted in the jurisdiction of the municipality which shall promote livelihood opportunities to its residents and boost the local revenue.

Section 2. Title. This Ordinance is entitled as stated and shall be also known as 2022 Imposition of Fees and Charges for Bulalacao Nights.


Section 3. Definition of Terms. As used in this ordinance, the following terms shall mean:


- a. **Bulalacao Nights** refers to an event of the municipality that shall be located at the Bulalacao Bay Park, Barangay Poblacion. It is a celebration of food, drinks, bright lights and different fun and engaging activities such as carnivals, live music, performances, sports fest, and contests and other similar activities.
- b. **Night Market** is one of the activities in the Bulalacao Nights which refers to the selling of different food, drinks, and souvenirs and other valuable items.
- c. **Ambulant, Transient or Itinerant Vendor/Peddler** refers to a vendor or seller who does not permanently occupy a definite place or stall in the market but one who comes either daily or occasionally to sell his/her goods.
- d. **Consumer** includes those who directly purchase or acquire from the manufacturers, producers, distributors, refiners or suppliers of articles or goods for their direct use for consumption or for distributions for the use or consumption of others as the end-users of ultimate consumers.




Section 10. Effectivity. This Ordinance shall take effect immediately after its approval.


