RESOLUTION IN THE MATTER OF CALLING SPECIAL SESSION WHEREVER IN CASE THE
AMOUNT OF BUSINESS SHALL REQUIRE, BE ADJOURNED FROM DAY TO DAY UNTIL
BUSINESS IS COMPLETED IN PURSUANCE TO SEC. 2220 OF THE REVISED ADMINIS-
TRATIVE CODE AS AMENDED OF 1917:

WHEREAS, the annual Municipal Budgets General Fund have not been
finished for devising all expenditures in the different offices, salaries,
expansions and other incidental expenses, audit and others necessary
items of the municipal government of Bulalacao, Oriental Mindoro for
fiscal years 1970 to 1971 till to the present time; and

WHEREAS, due to the incomplete revision of all items in the annual
Municipal Budget General Fund for the current year, the Municipal Coun-
cil of Bulalacao, Oriental Mindoro with two members of the Council hereby
called special meeting in compliance with the provision of section 2220
of the Revised Administrative Code of 1917 as amended, which said provi-
sion on section 2220 is hereby quoted verbatim as: The Mayor, or any two
members of the Council, may call a special meeting by giving written
notice shall be served personally or left at his usual place of abode."

IT IS, THEREFORE, on motion of Councillor Ulpiano C. Rindino and duly
seconded by Vice-Mayor Dolores S. Rigo, be it therefore resolved to call
special meeting on September 25, 1970 at 2:00 o'clock P. M. to finish
and revise the annual Municipal budget for the fiscal year 1970 to 1971
which was long over due for submission to the Provincial Treasurer for
approval; and

RESOLVED FURTHER, that during the meeting by majority votes the Vice-
Mayor Dolores S. Rigo has been unanimously selected to preside the special
meeting.
