MUNICIPAL APPROPRIATION ORDINANCE
NO. I FOR CALENDAR YEAR 1982.

WHEREAS, the Income Estimates of the Municipality of Bulalacao was submitted by the Municipal Treasurer to this Honorable Body in Session Assembled for study, adjustments and approval;

WHEREAS, upon careful study of the same and adjustments had been made, the Sangguniang Bayan hereby Ordains that:

Section I.- This Ordinance shall be known as Municipal Appropriation Ordinance No. I of the Municipality of Bulalacao for Calendar year 1982;

Section 2.- The Source of Income wherein the expenses be made shall be taken from the General fund amounting to ₱ 270, 423, 16 for various development projects of the Municipality, as well as the salaries/wages of Municipal employees and the expenses of different Offices thereof;

Section 3.- This Ordinance shall take effect immediately after its approval.

RESOLVED, FURTHER, that copies of this Appropriation Ordinance be furnished the Provincial Treasurer, Calapan, Oriental Mindoro for review and approval.
