RESOLUTION NO. 68 ✓

REQUESTING THE HONORABLE JUDGE, REGIONAL TRIAL COURT, BRANCH XLIII, ROXAS, ORIENTAL MINDORO TO EXCLUDE THE SIX (6) HECTARES OF LAND FROM THE TITLE OF JOSE MACAYA AND OR FROM THE TITLE OF NAME OF OTHER PERSONS OF SAME PROPERTY WHICH WAS CLAIMED BY THE MUNICIPAL GOVERNMENT FOR THE MARKET SITE, SCHOOL SITE AND MUNICIPAL GOVERNMENT SITE PURPOSES

WHEREAS, as per Resolution No. 31, dated May 30, 1970 of the Municipal Council of Bulalacao, Oriental Mindoro, six (6) hectares of land located at Campaasan, this municipality was claimed by the Municipal Government, to wit: Two (2) hectares for Market site, Two (2) hectares for school site, and two (2) hectares for Municipal Government site purposes;

WHEREAS, the Municipal government of Bulalacao has constructed a public market building in this site since in 1969 and now under operation and administration of the said government, peacefully and uninterrupted;

WHEREAS, this six (6) hectares of land which was claimed by the Municipal Government was titled in the name of one Jose Macaya and now under court litigation for the annulment of title;

WHEREAS, the Sangguniang Bayan representing the Municipal government of Bulalacao wants this six (6) hectares be excluded from the title of Jose Macaya and or from the title of name of other person of same property;

NOW, THEREFORE, resolved, as it is hereby resolved, to request the Honorable Judge, Regional Trial Court, Branch XLIII, Roxas, Oriental Mindoro to exclude the six (6) hectares of land from the title of Jose Macaya and or from the title of name of other persons of same property for the market site, school site and Municipal government site purposes of the Municipal government of Bulalacao;

RESOLVED, FURTHER, that copies of this resolution be furnished, the Honorable Judge, Regional Trial Court, Branch XLIII, Roxas, Oriental Mindoro, the Fiscal of same Trial Court for consideration and proper action.

There having no other business to be transacted so on motion of Hon. Leodigario Gonzales, seconded by Hon. Emelio Gregorio, the session was adjourned at 12:00 AM.
