REQUESTING DOCTOR HONESTO MALIWANANG, PROVINCIAL VETERINARIAN, CALAPAN, ORIENTAL MINDORO FOR ADDITIONAL SUPPLY OF VETERINARY MEDICINE FOR THE MUNICIPALITY OF BULALACAO, THIS PROVINCE

WHEREAS, Mr. Romeo Montojo, Officer-Incharge of the Ministry of Agriculture and Food and his field personnel had launched massive deworming and immunization of all kinds of ruminant animals against Hemoragic Septicimia in this municipality;

WHEREAS, as per report of Mr. Romeo Montojo to the Sangguniang Bayan on its Regular session held on November 17, 1986, 3kgs of Bithionol-S and a bottle of Hemoragic Septicimia is only enough for three (3) barangays and 12 more barangays had not been served;

WHEREAS, more supply of Bithionol-S and Hemoragic Septicimia are badly needed for the 12 unserved remaining barangays;

NOW, THEREFORE, resolved as it is hereby resolved, to request Doctor Honesto Maliwanang, Provincial Veterinarian, Calapan, Oriental Mindoro for more supply of Veterinary Medicines for the municipality of Bulalacao, Oriental Mindoro;

RESOLVED, FURTHER, that a copy of this resolution be furnished, Doctor Honesto Maliwanang, and Mr. Adolfo Comia, Provincial Agriculture and Food Officer, all of Calapan, Oriental Mindoro for consideration and proper action...
