RESOLUTION NO. 31 ✓

RESOLUTION IN THE MATTER OF RESERVING, ADJUDICATING AND PROCLAIMING, PORTION OF THE LAND COVERED BY LOT NO. 671, Fls-395-D FOR THE SITES OF BULALACAO PUBLIC MARKET, COMMUNITY HIGH SCHOOL, AND MUNICIPAL GOVERNMENT SITE IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO:

WHEREAS, for the construction of public market, Pre-Fabricated School building for the community High School and for other purposes, a portion of Lot No. 671, Fls-395-D, of the land is greatly necessary and needed therein to construct said public buildings;

WHEREAS, in Bulalacao Public Land sub-division a portion of the land covered by Lot No. 671, Fls-395-D, there available and best sites for the erection of government buildings which are accessible and feasible for any transportation facilities; and

WHEREAS, public buildings, to be constructed in any site or area must be owned and possessed to, in favor of the municipality the Republic of the Philippines; and

On motion of Councilor Ulpiano C. Pandino and duly seconded by Councilor Jessie Gado, be it

NOW, THEREFORE, resolved, as it is hereby resolved, by this body, the Municipal Council of Bulalacao, Oriental Mindoro, and for and in the interests and benefit of the Municipal Government of Bulalacao and of the people in general, the Municipal Council hereby freely reserve a part and portion of the land covered by Lot No. 671, Fls, 395-D, in the site of Campaasan, Poblacion, Municipality of Bulalacao,, for the site of Public Market, Community High School and for other purposes to wit as: 1.- Two (2) hectares of land reserves and adjudicated to public Market excluding roads allowance, 2.- Two hectares of land reserve and adjudicated for the Community High School and 3.- Two hectares (2) of land reserve and adjudicated for Municipal government site; and

RESOLVED, FURTHER, that the above-mentioned sites as herein specified in this resolution, be declared and proclaimed to be the government property, the Municipal government of Bulalacao, Province of Oriental Mindoro, Republic of the Philippines, from now and henceforth.


