RESOLVED, to approve the following Ordinance:

ORDINANCE NO. I

AN ORDINANCE REQUIRING PROSPECTIVE MARRIED COUPLE TO ATTEND PREMARRIAGE COUNSELLING

Be it ordained by the Sangguniang Bayan of Bulalacao,

T h a t:

SECTION 1. Prospective married couple shall attend Premarriage Counselling to be conducted by accredited Premarriage Counsellors before issuance of marriage license by the Local Civil Registrar, as required by PD 965;

SECTION 2. Accrediated Premarriage Counselors are composed of representatives of Ministry of Health, Population Commission, Municipal Government of Bulalacao and Private Sector;

SECTION 3. Married couples shall pay P10.00 as Registration fee to the accredited Premarriage Counselling Team aside from the P5.00 Family Planning and Counselling Service Fee now being collected by the Office of the Municipal Treasurer;


SECTION 4. P10.00 Registration fee shall be spent for the office supplies of the Premarriage Counselling Team and 10% of this collection shall be remitted to the Oriental Mindoro Premarriage Counsellors Association (ORMPMCA) Fund;

SECTION 5. All Ordinances inconsistent with the Provisions of this Ordinance are hereby repaled or modified accordingly;

SECTION 6. Effectivity- This Ordinance shall take effect immediately.
