" RESOLUTION NO. 93-08-059

REQUESTING THE PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO TO APPORTION THE FIFTY PERCENT (50%) OF THE MONEY COLLECTED OUT OF THE PENALTY IMPOSED UNDER SECTION 2-A.08 PAR (3) OF THE REVENUE CODE OF THE PROVINCE OF ORIENTAL MINDORO TO THE MUNICIPALITY WHERE THE LOTS OWNED BY THE PERSONS PENALIZED ARE SITUATED

"WHEREAS, Section 2 A.08 par (3) of the Revenue Code of the Province of Oriental Mindoro obliged any person, or his authorized representative, acquiring at any time real property situated in any municipality on making any improvement on real property, to prepare, or cause to be prepared, and file with the Provincial/Municipal Assessor, a sworn statement declaring the true acquisition cost or fair value of subject property, within sixty (60) days after the acquisition of such property or upon completion or occupancy of the improvement, whichever comes earlier;

"WHEREAS, sub par (d) of the same provision of the mentioned Code provides that property owners or administrators and other persons acting in their behalf who fail to comply with the above shall be subject to a fine of Five Hundred Pesos (P500.00)!

"WHEREAS, the money collected out of this imposition goes entirely to the provincial coffers denying the municipal government, of which employees implement the particular ordinance, with substantive and equal share;

"WHEREAS, while Section 271 of RA 7160, otherwise known as Local Government Code of 1991, is not absolutely explicit, it can be deduced that lower local government units are entitled to a share on all the proceeds of real property tax including the penalties imposed by Provincial Tax Code;

NOW THEREFORE:

RESOLVED AS IT IS HEREBY RESOLVED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro to request the Provincial Government of Oriental Mindoro to apportion the fifty percent (50%) of the money collected out of the penalty

imposed under Section 2-A.08 par (3) of the Revenue Code of the Province of Oriental Mindoro to the municipality where the lot owned by the persons penalized are situated;

RESOLVED FURTHER, that copies of this Resolution be furnished the Provincial Governor, the Sangguniang Panlalawigan, the Provincial Treasurer and Provincial Assessor, all of Calapan, Oriental Mindoro for their information, consideration and kindest approval.

RESOLVED FURTHERMORE AND FINALLY, to submit copies of this Resolution to the Sangguniang Bayan of the fifteen (15) municipalities of Oriental Mindoro for their information and appropriate action.
